V. CHIEF'S REPORT

Four of the new desktop computers have been configured and put into service. The remaining upgrades will be completed over the next few weeks.

The new Fire Marshal is making headway and working through issues with FDSU. The FEMA Fire Act Grant is written and is being proofed. It will be submitted tomorrow. We are asking for funding for 24 sets of SCBA's (a set includes 2 tanks, harness/backpack, regulator and facemask), 10 particulate hoods, and 17 respirators. The total cost is \$420,000 but our share will only be \$20,000.

FEMA SAFER Grant: Opens on February 13th. The total amount we can ask for is

\$20,000.

It's time to clean our ventilation system. Captain Campagnola is in the process of getting quotes.
