I. MEETING CALL TO ORDER

The meeting was called to order at 18:00 hours.

II. PUBLIC COMMENT/RECOGNITION

An old, out of service, brush pump will be donated to an organization that facilitates donations to small departments with minimal budgets.

IT computer upgrades are in progress.

Bill Diershow, the new part-time Fire Marshal, has started working and is making a lot of headway. He will be begin performing commercial property fire inspections and pre-plans in January. He has submitted a very comprehensive fire investigation SOG and has begun

preparation work for our next ISO inspection.

There has been no movement of the ambulance grant other than the completion of the second quarter progress report.

LFPD will be issuing a federal grant submission next week. The grant submission will be for approximately \$20,000. This submission will be for funding from a grant we have already been approved for. The submission is necessary for the funds to be released to us.

The FAMLI Leave Insurance Program opt-out documentation has been submitted to the State as required by law. Also, as required by law, LFPD employees have been notified to the District's decision to opt-out and that they, as individuals, have the right to opt into the program.
