- Help decorate the outside of the station a little bit.
- Medic Turbo is bad, \$9,800 to get fixed.
- Implementing a new fee schedule for event permits per the Fire Marshal.
- Fire Academy graduation tomorrow, Nov. 10 at 9:00 a.m.
- Paramedic hiring panel on Saturday, Nov. 11
- Working with a previous paramedic candidate to improve and apply in the future.
- Still pursuing State Forest recovery
- Fiscal 2023 Budget
 - Fixed wall/ceiling leak at Station 162 workout room
 - Identified ceiling leak in Station 161 bay
 - Exterior paint colors for Station 162
 - Interior painting approved for Station 161
 - Station 164 need exterior wall repaired before exterior painting
 - Station 162 still needing estimates for sprinkler hook up
 - Cistern on Lake Gulch Road discontinue and go to the unfenced area for new cistern
 - Looked at 2023 budget items and determined line items to be adjusted
- Amended line items in proposed Fiscal 2024 Budget to pull into 2023 Budget
 - No election expenses
 - No command vehicle purchased in 2023 (capital purchase)
 - Refurbished Life Pak
 - AEDs on wildland trucks and command vehicles
 - UTV/ATV purchase working with West Metro Fire
 - Trailer purchase to pull UTV/ATV
- Look at event/party in December at Station 161 staff and Union in the planning
- Salary modification reduced salaries for Deputy Chief and Fire Chief
- Budget Capital items are being individually noted
- Chief Walden stated to go forward with eliminating the Firefighter of the Year award
- MOU reviewing Mutual Aid Agreement with Jackson 105 for purposes of Fire Investigation

- Mr. Greer asked about Proposition HH did not passing, will it affect us as a fire
 department? Chief Walden said he believed would not affect us significantly (reduction
 in income tax, slight reduction in property evaluations and making it more friendly for
 persons that are retired to have a one-time exception).
- Mr. Greer asked about putting together a bonus package for the December meeting for individuals. Chief Walden said he has already taken care of this and there is only one remaining individual.
- Mr. Chambers asked if there were any comments on incidents happening in our district. Chief Walden commented on the most recent calls.
- Mr. Greer asked about the retention panel information and Chief Walden asked FF Mike Pelka to speak.
 - New Wage Scale with Low/Mid/High Performers Criteria
 - Incentives program
 - Pay differentials
 - Each step grade separated by years of service 5.2% increase between each one
 - Performance level (ABC) 4% difference
 - Probationary levels for Paramedics and EMTs
