- Mr. Moore asked why employee assistance/peer support budget went up so much? Chief Walden stated that the programs are geared toward individuals and families.
- Mr. Greer asked where the coordinator position money came from. Chief Walden stated that they are showing up in the wages.
- Mr. Moore asked if the volunteers are covered in the disability insurance and Chief Walden stated the volunteers are covered.
- Mr. Chambers asked if the ending balances of 2023 should be estimated or final numbers. Chief Walden explained that 2023 invoices still are outstanding and need to be paid so it needs to stay as estimated.
- Mr. Greer asked where in the budget does the wildland reimbursement recovery show.
 Chief Walden states that the recovery is 2022 funds and will go into the savings account.
