All candidates must be at least 18 years of age and must take the FireTEAM exam through the National Testing Network (NTN) by June 10, 2022. Additionally, all candidates must complete the Personal History Questionnaire (PHQ) and the Public Safety Self-Assessment (PSSA) through the National Testing Network by June 10, 2022.

Interested applicants must upload the following required documents and certifications to the NTN website no later than June 10, 2022:

1. A resume with cover letter
2. GED, High School, or College Diploma
3. Current Colorado State Paramedic certification **OR** National Registry Paramedic certification
4. Current AHA Healthcare Provider Basic Life Support Provider card or equivalent
5. Current AHA Advanced Cardiac Life Support Provider card or equivalent
6. Current AHA Pediatric Advanced Life Support Provider card or equivalent

The following additional **preferred** certifications should be uploaded to the NTN website no later than June 10, 2022 if the candidate possesses them:

1. NWCG Wildland S130/190 (expected to obtain within 6 months of hire)
2. Current IFSAC or Pro Board endorsed Driver Operator Utility (expected to obtain within 6 months of hire)
3. Current IFSAC or Pro Board endorsed Firefighter I (expected obtain within 6 months of hire)
4. Current IFSAC or Pro Board endorsed Hazmat Operations (expected obtain within 6 months of hire)
5. National Incident Management System ICS 100, 200, 700, 800 (expected obtain within one month of hire)
6. Current Candidate Physical Ability Test (CPAT) certificate

Following an internal application review process, the most qualified applicants will be invited via email no later than June 15, 2022 to participate in Phase 1 of the testing process. These testing components will be conducted at LFPD Station 161, 9414 Spruce Mountain Road, Larkspur, Colorado, 80118. Applicants must bring their current driver's license with them to the first day of evaluations as proof of identity. The Phase 1 testing schedule is as follows:

1. Larkspur Physical Ability Test (LPAT): June 29, 2022 (**Proof of a current CPAT certificate included in the employment packet will negate the LPAT requirement**)
2. Firefighter and EMS Skills Evaluations: June 30, 2022
3. Oral Board Evaluations: July 1, 2022

Candidates who successfully complete Phase 1 testing with desired scores will be notified no later than July 6, 2022, of their eligibility to continue to the final phases of the process. The final phases are as follows:

1. Chiefs Interview: Date to be determined
2. Background Check: Date to be determined
3. Medical and Psychological Fitness Examinations: Date to be determined

The anticipated start date for selected candidates is August 1, 2022.

Candidates who score satisfactorily on all testing components but are not selected for immediate employment will be placed on a hiring list which will be a resource to fill future full-time and part-time position vacancies. The list will remain in effect until the Chief of the District determines another list and testing process is necessary.
