I. MEETING CALL TO ORDER

Mr. Greer called the meeting to order at 6:01 p.m. hours.

III. CONSENT AGENDA

A. August 10, 2023, Pension Meeting Minutes

A motion was made by Mr. Vance and seconded by Mr. Chambers to approve the August 10, 2023, Pension Board minutes, as presented. All were in favor and the motion carried.

- B. Financials Mr. Ott spoke to the following:
 - -2023 Actuarial report which shows a strong financial position. LFPD required amount to contribute by statute is \$45,758 (minimum required by law) which includes the DOLA contribution of \$28,338.
 - Allocation Report financial status for third quarter 2023, return on investment loss of 2% on investment fund (\$75,000). There is a 4% return on money and trying to get to 5.8% (break even goal) which is doable in the fourth quarter.
 - -Actuarial Study of Retirement Plans Plan A is out (cut benefits by \$40 per month); Plan B is considered for 2024 and Plan C for late 2024/early 2025. Table discussion until next meeting to evaluate 2023 fourth quarter.

A motion was made by Mr. Ott to maintain the \$740 per month basic twenty-year vested payout for this quarter and continue with that in accordance with the actuarial study, seconded by Mr. Vance. All were in favor, except Mr. Greer abstained from voting and the motion carried.

A motion was made by Mr. Ott to change the 2024 contribution amount from \$56,000 to \$52,000 in the 2024 budget, seconded by Mr. Chambers. All were in favor and the motion carried.
